## DKV Mobility and LIQVIS commit to a joint fuel card

- **LIQVIS customers to benefit from Europe's largest LNG network through cooperation with DKV Mobility**
- **Cooperation makes it easier for customers to reduce their CO<sub>2</sub> intensity**

**Ratingen, 02.08.2021.** The European mobility service provider DKV Mobility is cooperating with the Essen-based company LIQVIS from August 01, 2021. LIQVIS GmbH, a subsidiary of Uniper SE, offers LNG for the transport and logistics industry. As part of the new cooperation, the company is replacing one of its previous payment methods - the LIQVIS Token - with a joint LIQVIS and DKV Mobility fuel card. With the "LIQVIS card", LIQVIS customers will in future not only have access to the company's own LNG network, but also to DKV Mobility's comprehensive supply network and consequently the largest brand-independent LNG network in Europe. DKV Mobility currently offers access to more than 230 LNG stations in nine countries. DKV Mobility manages the administration and billing of the joint fuel card.

**Sven Mehringer, Managing Director Energy & Vehicle Services says:** "Through the cooperation with LIQVIS, we have the opportunity to further advance the future of sustainable mobility. LIQVIS and DKV Mobility have similar goals and this unique collaboration will help us to achieve these goals. One promise we have made is to help our customers reduce the CO<sub>2</sub> intensity of their fleets by 30 percent by 2030 compared to 2019. This cooperation brings us another step closer to that promise."

DKV Mobility is one of the leading mobility service providers for the logistics and transport industry for over 85 years and currently has over 1,300 employees.
